St. Clair County Offices Re-Open to the Public

With the rescission of Governor Whitmer's Stay at Home Executive Order, St. Clair County Offices will re-open to the public effective 06/15/20 at 8:00 a.m. We are requesting citizens to continue to access services whenever possible online, via mail or via drop box. The Treasurer's Office will conduct in-person services by appointment only. Please call (810) 989-6915.

Health Department services will be available by appointment only. Please call (810) 987-5300 for more information.

St. Clair County Court Operations will be conducted within guidelines issued by the State Supreme Court Administrator's Office. Specific questions regarding Court operations can be addressed by contacting the appropriate court, as listed below.

The St. Clair County Library System will be implementing a phased-in approach to reopening. This will allow employees to establish all necessary safety precautions and procedures. Library materials can be returned beginning June 22, 2020 through the use of drop boxes only. Donations of books will not be accepted. The next step will include curbside, touchless circulation. It is anticipated this will begin prior to July, but will be determined by technology and staffing requirements.

This plan includes a comprehensive list of all protective measures established to protect employees and citizens.

Operations will be conducted in accordance with the guidelines issued by Governor Whitmer's Executive Order 2020-114, or any order that follows it. Specifically:

- All employees and citizens will be screened prior to entering the facility.
- Face coverings are required to be worn by employees, and citizens in any common space in the facilities.
- All employees and citizens should practice proper social distancing, maintain a distance of 6 feet.

- Contact barriers have been installed at service windows, reception desks and counters, where feasible.
- Hand sanitizer has been placed on all public counters.
- Tele-conferencing rather than in-person meetings are strongly encouraged.
- Conference rooms remain closed for use and locked, when feasible.
- All non-essential travel is prohibited and employee Motor Pool vehicles are not available for use.
