**Brownfield Redevelopment in St. Clair County**

In 2017, the St. Clair County Brownfield Redevelopment Authority (SCCBRA) was awarded a \$4000,000 Brownfield Coalition Assessment Grant from the U.S. Environmental Protection Agency (EPA) to assess contaminated or ***potentially*** contaminated sites (brownfields) in St. Clair County. Its Coalition partners include: the SCCBRA, St. Clair County Land Bank Authority, the Cities of Port Huron and Marysville, and Port Huron Township. With these funds, the SCCBRA and its Coalition members will help return abandoned, underutilized and typically contaminated properties in our communities to productive use.

The SCCBRA is seeking possible sites for these grant funds. The sites you nominate may be included in a County-wide inventory that is being developed by the SCCBRA. These sites may be owned by a local unit of government (LUG) or privately held with potential interest from a developer or a need for site preparation to encourage redevelopment. Please nominate a possible site(s) in your community that may benefit from this opportunity.

As the SCCBRA develops the list of potential sites, it will only include sites that are part of the public record with respect to environmental issues, and/or the property owner approves of the site being included on the list.
