

RESOLUTION 16-47

REVISING RESOLUTIONS 10-11, 09-33, 06-28, 05-31, 01-42 AND 97-63 ADOPTING NEW FEE SCHEDULE FOR DOG LICENSE FEES AND REMUNERATION FOR ISSUING AND RECORDING DOG LICENSES.

WHEREAS, the Board of Commissioners of St. Clair County pursuant to M.S.A. 12.516 has the authority to prescribe the fees necessary to properly finance the Animal Control Program for the County of St. Clair, Michigan, and

WHEREAS, the current fee schedule has been in effect since December 15, 2011

NOW, THEREFORE, BE IT RESOLVED, that effective December 9, 2016, the following fee schedule shall be in effect:

ANNUAL LICENSE FEES (applies to those dogs who have reached four(4) months of age or who are obtained prior to March 1):

*****All animals rescued will require a SPAY/NEUTER \$25.00 deposit placed on the animal which will be refunded to the rescue agency if proof of spaying/neutering is provided to the Animal Control Office within 30 days of the rescue or within 30 days of the animal turning 6 months of age.*****


